## American College of Cardiology National Cardiovascular Data Registry and Accreditation - All Hospital List User's Guide

**Purpose:** This document is a user's guide for the American College of Cardiology (ACC) National Cardiovascular Data Registry (NCDR®) and Accreditation Services - All Hospital List data download. It contains the file structure, record inclusion criteria, and a data dictionary.

#### A. Background

#### **B.** File Content Description and Structure

- 1. The All Hospital List data download contains all facilities affiliated with the American College of Cardiology as defined by participation in at least one ACC in-hospital data registry, the Quality Improvement for Institutions program, or ACC Accreditation Product.
- 2. The hospital list contained in the download file is refreshed daily. Hospitals who sign a new contract with the ACC will be added to the list within approximately one business day. Hospitals whose contracts expire will likewise be removed from the list within approximately one business day.
- 3. The file is a Microsoft Excel Comma Separated Values File (.csv).
- 4. The first row of data contains a header row with the column name of the field.

5. Each subsequent row within the file represents a unique site (i.e. hospital, cath lab, etc.) that has an active contract in at least one American College of Cardiology's data registries, the Quality Improvement for Institutions program, ACC Accreditation Products.

#### C. Data Dictionary

1. The table to follow describes each of the fields available in the All Hospital List data download. All data contained in this download is self-reported by the facility and/or is derived from the contractual status for the respective registry/program. The ACC does not validate self-reported hospital demographic information.
